• **TERMS**

- Americas Attic reserves the right to refuse or dispose of any items that may have smoke, mold, pet, structural and soil damage.
- Items will be accepted for a 90 day consignment period, starting from day that they are placed on the sales floor. After 180 days, all unsold items become property of Americas Attic.
- Americas Attic will establish and set the pricing on all consigned items. We will always strive to secure the best possible price for your item based on manufacturer, quality, condition and marketability of the piece.
- Inventory will reduced in price via a preset markdown schedule. There is a progressive price reduction of 10% every 15 days. Discounts and promotions are at the discretion of Americas Attic.
- If items are requested to be reclaimed prior to end of the consignment period, there will be a restocking fee of 30% of the starting price that is payable prior to the items being picked up.
- Consignors agree to pay a \$75 local flat rate pickup fee plus NYS Sales Tax (if service is provided), taken out of proceeds of sales.
- All items consigned with Americas Attic remain the property of the consignor. While all reasonable efforts will be made to keep consigned items clean and safe from damage; Americas Attic inc. is not responsible for LOSS or DAMAGE to consigned articles from fire, water, theft, damages or other casualty. Please ensure that all items are covered under your homeowner's policy or such other insurance as you deem appropriate.
- All individual items priced at \$20 or below that are unsold or not retrieved by the consigner from Americas Attic after 90 days becomes the sole property of Americas Attic.

- **COMMISSION**

- I understand my share is 50% of the final selling price for items sold within the 90 day consignment period.

- A handling fee starting at \$.99 on up will be added to each item depending upon its price and helps to cover credit and debit card processing fees. This small fee is paid by the buyer, not the consignor. The consignor's payout will be based on the final selling price.

- **UNSOLD ITEMS**

- If you wish to retrieve your unsold items, you must do so within 5 days after the end of the consignment period. We retain the right to sell those items until they are removed by the consignor. Unless otherwise specified, items left in the shop 5 days after the consignment period ends will be donated to a charitable organization or liquidated at the discretion of Americas Attic.

- Allow UNSOLD items to be:

PAYMENTS

- Checks are cut on or after the 15th of each month for the previous month's sales for balances over \$25. There will be a \$2 processing fee per monthly payment.
